The Work includes, but is not limited to, the following: select interior demolition and remodeling of the existing kitchen including new wall construction, painting, tiling, lay-in ceilings, and limited HVAC and electrical modifications. Contractors shall not pay less than the Cook County prevailing rates of wages to all laborers, workmen, and mechanics performing work under this contract, and shall comply with the requirements of the Illinois Wages of Employees on Public Works Act (820 ILCS 130/1-12).
